Extract From Rules

Any person or firm who makes application for registry or transfer of an animal thereby subjects himself to, and agrees to be bound by the By-Laws and Rules of the Association.

It shall be the duty of each member or other person registering cattle with this Association to keep accurately, on all service-age females in the herd that are eligible for registry, a complete record showing date of service or insemination, name and registration number of animal serviced or inseminated, name of sire used, date of calving, sex and identification of offspring.

The breeder of an animal is the owner of the dam at the time of service. The first owner of a calf is the owner of the dam at the time the calf is born. The applicant for registry is the owner of an animal at the time of application for registration is made. In cases where the applicant for registry is not the first owner, necessary transfers will be required.

In addition, animals bred by the owner of the Farm Name, even though the bred animal may not be owned by the Breeder at the time of birth, shall be registered with the prefix of the breeder.

Animals identified by **TATTOO** must have two (2) or three (3) letters reserved with the Association. Upon receipt of the Certificate of Registration of animals not tattooed, a photo or a sketch of the correct animal must be affixed to the front of the certificate. If a certificate of registry is lost, duplicate certificates are issued at a fee of \$8.00.
