## **Excerpts from rules governing membership:**

Only owners of Ayrshire cattle as indicated by the records of the Ayrshire Breeders' Association shall be eligible for membership. One or more members of the Association shall recommend each applicant for membership in writing. The name of each applicant for membership shall be presented to the Board of Directors. If no objection in writing is offered by any member of the board, the applicant shall be accepted.

Each member agrees to be bound by the by-laws and rules and regulations of the Association and failure to abide by the same may make said member subject to expulsion and censure under the provisions of the by-laws.

After the death of a member, his executor or the administrator of his estates shall have the right to register and transfer animals for a period of eighteen months upon same terms and conditions as the member would have if living.

Membership may be granted in the name of an estate being administered by an executor, administrator or trustee of a deceased person, whether or not such deceased person was a member of the Association. The fee to be charged such an estate will be as stated above. The membership shall continue only so long as the estate is being administered and shall therefore be terminated when the estate is closed.
